

## 貨物轉口產地來源證申請手續

### Application Procedures for Re-export Certificate of Origin

本會提供簽發貨物轉口產地來源證服務，詳情如下：

The Chamber provides the service of issuing re-export certificate of origin, please see details below :

#### (A) 申請手續 *Application Procedures*

- (1) 填寫本會提供的申請表格。  
Fill in the application form obtainable from the Chamber.
- (2) 填寫本會提供的貨物轉口產地來源證書(一式三份)。  
Fill in the re-export certificate of origin forms (3 copies: original, copy, triplicate) obtainable From the Chamber.
- (3) 每次申請必須提供貨物原產國供應商簽發之商業發票及運輸文件(提單/空運提單)或由原產地簽發之出口文件(出口許可證，出口清關文件或香港入口載貨清單)。  
Each application should be submitted together with the **copy of the corresponding import /export documents** of that particular shipment / transaction (if any) from the supplier of the originating country.
- (4) 遞交香港商業登記證副本一份  
Submit a copy of the business registration certificate.
- (5) 遞交本會認為需要之其他有關文件  
Submit documents requested by the Chamber.
- (6) 加簽後的文件可於簽發日期後之一個月內免費修改。  
Amendment can be made free within 1 month from the date of endorsement.
- (7) 簽發需四小時  
Processing Time : 4 hours

\*\*備註: 已離港轉貨物之後補加簽，必須在到達目的地前並不多於離港後 14 日遞交申請文件，本會恕不受理過期文件。

\*\*\*P.S. For cargo already departed from Hong Kong, customers have to submit the application form before the arrival date of the destination, and within 14 days of departure.

#### (B) 收費 *Charges*

首套文件收費 HK\$210; 如同時間遞交多於 1 份或以上，其後每套收費 HK\$190。

HK\$210 for the first set of documents, HK\$190 for the subsequent sets if submitted on the same day.
