## **Certified Documentary Credit Specialist (CDCS) Training Course 2019**

### *Introduction:*

CDCS is a professional certification that enables documentary credit practitioners to demonstrate specialist knowledge and application of the skills required for competent practice. The CDCS program was designed in consultation with industry experts to ensure that the certification reflects best practice. It was developed by the London Institute of Banking and Finance (LIBF) in partnership with the International Chamber of Commerce (ICC).

To satisfy the demands of CDCS students and those who want to enhance their trade knowledge and practice, ICC-HK has organized a CDCS training course in January 2019.

### *Highlights:*

This training focuses on the Guide to Documentary Credits (consisting of more than 450 pages) except for the various ICC rules. The Guide is the CDCS examination syllabus. On completion of this course, the participants will have the overall knowledge and understanding of the syllabus and trade finance, which is a must and an invaluable asset to take the examination. As a matter of fact, whether a participant sits for the CDCS examination, this course equips the participant with the essential and practical trade knowledge and understanding.

### *Who should attend:*

- Candidates who will be sitting for CDCS examination in 2019 and beyond
- LC practitioners who want to enhance their trade knowledge and practice

### Speaker:

**Mr. Jack Chan** was a senior vice president and the senior trade technical advisor of Wells Fargo Bank, N.A. Hong Kong and retired recently. He was in the banking industry for more than 42 years. Mr Chan provided trade advisory to and conducted many trade seminars (on UCP, ISBP, eUCP, ISP98, Risks, Case Studies, etc.) for his ex-colleagues and customers throughout the world. He was also invited by some professional bodies (e.g. ICC Austria / Thailand, Bankers Institute of the Philippines & Hong Kong Institute of Bankers) to conduct trade seminars. In 2002, Mr Chan sat for the CDCS examination and passed with distinction. In 2005, he went up to mainland China to establish the Shanghai Branch of Wells Fargo Bank, N.A.
