



# Certified Documentary Credit Specialist (CDCS) Training Course 2016

## Introduction:

CDCS is a professional certification that will enable documentary credit practitioners to demonstrate specialist knowledge and application of the skills required for competent practice. The CDCS program was designed in consultation with industry experts to ensure that the certification reflects best practice. It was developed by the Institute of Financial Services (*ifs*) University College in partnership with the International Chamber of Commerce (ICC).

To satisfy the demands of CDCS students, ICC-HK has organized a CDCS training course in February and March 2016.

## Highlights:

This 12-hour course focuses on the recently revised Guide to Documentary Credits (5th Edition) where detailed analysis will take place except for the ICC rules. The 5<sup>th</sup> edition consists of 25 chapters whereas the 4<sup>th</sup> edition of 13 chapters. The Guide to Documentary Credits is the CDCS examination syllabus. On completion of this course, the participants will have the overall knowledge and understanding of the syllabus, which is a must and an invaluable asset to take the examination. As a matter of fact, whether a participant sits for the CDCS examination, this course equips the participant with the essential trade knowledge and understanding.

## Who should attend:

Candidates who will be sitting for CDCS examination in 2016 and beyond.

## Speaker:

**Mr. Jack Chan** is a senior vice president and the senior trade technical advisor at a leading U.S. bank in Hong Kong. He has been in the banking industry for nearly 4 decades. Mr Chan provides trade advisory to and conducts many trade seminars (on UCP, ISBP, eUCP, ISP98, Risks, Case Studies, etc.) for his colleagues and customers throughout the world. He was also invited by some professional bodies (e.g. ICC Austria / Thailand, Bankers Institute of the Philippines & Hong Kong Institute of Bankers) to conduct trade seminars. He is currently the chair of Asia Advisory Council of the Institute of International Banking Law & Practice Inc. (IIBLP), Maryland, USA. In 2002, Mr Chan sat for the CDCS examination and passed with distinction.
