

Contracts (Right of Third Party) Ordinance Cap 623

Introduction:

With the Contractual (Right of Third Party) Ordinance Cap 623 (the "Ordinance") becoming effective on 1 January 2016, it is important to know its impacts for all contractual arrangements, from agency and distribution agreements, sales and purchase agreements, licensing agreements, insurance contracts, to employment contracts etc..
