

# **Update on Data Privacy and Cybercrime**

#### **Introduction:**

Data privacy and cybersecurity issues impact every industry as evidenced from the recent data leakage and cyber attack incidents. While continuing innovations in information and communication technology bring convenience and business opportunities, they also present new challenges to Hong Kong's businesses and their senior management.

The recently enforced European Union (EU) General Data Protection Regulation (GDPR) may impose further obligations on Hong Kong companies, given its extra-territorial effect.

In this seminar, Ms Jill Wong, the speaker, will review hot topics concerning the Personal Data (Privacy) Ordinance and the application of EU GDPR to Hong Kong. She will discuss the regulators' expectations regarding cybersecurity and how to mitigate the damage from data breaches and cybercrime. Enforcement trends and case studies will also be discussed.
