# A Whole New World Security of Payment Legislation for Construction Industry (Zoom Webinar)

### 1 Law Society CPD Point being applied for



### **Introduction:**

A **new law** will be enacted to govern payments in the public and private construction projects in Hong Kong. This new law will abandon the conventional *"back-to-back"* or *"pay-when-paid"* payment philosophy and provide prompt adjudication of payment disputes.

Rumour has it that the Panel on Development of the Legislative Council will discuss the legislative framework of the Proposed Construction Industry Security of Payment Bill in early 2023 for implementation later on in the year.

# <u>Highlights:</u>

## Speakers will cover:

- 1. the present status of *"back-to-back"* or *"pay-when-paid"* provisions in the local construction industry;
- 2. how this new security of payment arrangement will affect the construction industry;
- 3. what new obligations will be imposed upon the parties; and
- 4. what parties should do to protect their rights under the relevant contracts and subcontracts.

In this seminar, the speakers will also share some practical tips and tactics to avoid construction disputes and what the likely implications may be under the Proposed Construction Industry Security of Payment Legislation.
